#### Welcome

 The PTA Chairman, Mrs.Sundari Jaishankar chaired the meeting, ascertained the quorum and declared the meeting was in order. Apology from Members absent was read and accepted.

She welcomed the Executive Committee members and the Management representative, Mr.Vikram Deshmukh

#### Confirmation of Minutes of the meeting

- The principal read and confirmed the minutes of the meeting held on 9th of October 2021.
- She briefed the parents the details of the fee collection after the parents meeting held in October. She informed the members that 55% of the parents paid the fees till the date and 45% still not paid the fees. She added saying that the parents should start paying the fees so that the school can smoothly.

#### School fee proposal for the Academic year 2022 -23 & 2023 -24

- The Principal informed the parents that the last fee revision was done in the year 2016 for the academic years 2017 -18 & 2018 -19.
- The school did not propose any fee revision for the academic 2019 -20. Instead, followed the same fee structure of the year 2018 -19.
- In November 2019, the school proposed fee revision of up to 15% for the academic year 2020 -21 & 2021 -22.
- The fee revision was not implemented for the academic year 2020 -21 due to pandemic.
- In May 2021, the school implemented the fee revision for the academic year 2021 but withdrawn the implementation due to the parents request.
- The Principal added saying that as the school is following the same fee structure for the four consecutive years, it is very much needed now to revise in order to sustain and to maintain the standard of teaching -learning process.

- The Principal announced that the school proposes the fee revision of 15% increase in accordance to (1B) of section 6 of Fee regulation act. The revised fee will be implemented for the next two academic years 2022 -23 and 2023 -24.
- She also informed the members that along with the fee revision the school has taken
  measures to standardize the fee structure. She read out to the members the class
  wise fees fixed after standardization.

#### Open Forum

1. Mrs. Asha Korana asked , What measures the school has taken to recover fees from the parents who did not pay the fees yet?

The Principal answered saying that the school is sending regular reminders to the parents through mail, Whatsapp and Telephonic call. Also, the management fixed a meeting with the parents on weekends to understand their problem and to try and give a suitable solution. Unfortunately, a very few parents turned up for the meeting.

The Management Representative, Mr.Vikram Deshmukh said that the school does not want to take any coercive action against any student instead, wants to give time to the parents to pay the fees till this academic year gets over. At the end of the year the school will decide what action to be taken against the parents who failed to pay the fees for more than one academic year.

- Mr.Rakesh Kadam welcomed the school's decision of standardization and said that
  this will rule out the confusion among the parents. All the parents will be charged
  the same fee irrespective of year of admission.
- Mr.Sagar Falle requested the management to explain the method of calculation done for standardization.

Mr.Vikram Deshmukh explained saying that the fee revision of 15% increase is calculated based on the lowest fee structure of that class, accordingly the other fees are calculated so that all come under same fee structure.

4. Mrs. Asha Korana said that some of the parents may oppose for the 15% fee revision. What should be the role of the Executive Committee members in this fee proposal?

Mr.Vikram Deshmukh said that as per the Fee regulation act section 6 point 1B, the school can propose fee with revision up to 15%. Also, the school did not revise the fees since 2016. The school needs to revise and implement the fee revision to sustain and to run smoothly. He also stated that the new amended fee regulation act says that the Executive Committee members be informed of the fee revision before announcing the same to the rest of the parents. If the fee revision is 15% then it does not require EPTA approval. Also, the EPTA members will be in a better position

to explain the other parents if they are briefed by the school about the fee revision well in advance. If the parents need more clarification can visit the school and meet the Principal.

### Other Discussions

## School Reopening

- 1. The Principal informed the parents that the physical school will reopen on 1st of December for the students of grade 8 and 9 as announced earlier. She added saying that 50% of the parents have given consent to send their wards to the school. Hybrid mode of teaching will be in place from 1st of December to facilitate the students who opted to attend online classes. School bus facility is made available.
- COVID safety measures will be strictly followed by the school. Infirmary is well equipped and Nurse is on duty.

Dr. Savita Pasalkar asked what arrangements the school has made if there is a power cut on Thursdays. The Principal answered saying that the school has generator backup, from school end we can conduct the classes on Thursday even if there is a power cut. For the students the school will record that days live classes and share it with the students so that they do not miss out any lecture.

### Sports Club

The Principal announced that the evening sports club activities will start functioning from 1" of December. Notification for the same is sent to the parents.

The parents welcomed the decision of starting the sport clubs for the students.

#### Vote of thanks
